11th January 2020. The process of approving the SSR done by the NAAC. The College has been Pre-qualified for submitting SSR on 25th February 2020. Peer Team Visit was scheduled by NAAC on 27th & 28th March 2020. But due to Covid – 19 pandemic situation, the visit was postponed. Now the NAAC has given revised date of visit on 27th 28th November 2020.
