RULES AND REGULATIONS:

1. Name of the Society : SMT. DUVVURU RAMANAMMA SOCIETY FOR WOMEN AND CHILD WELFARE: GUDUR: NELLORE DT.
2. Location of Office : The Office of the Society shall be located at DUVVURU RAMANAMMA COLLEGE FOR WOMEN: GUDUR : NELLORE DT.
3. FUNDS : Shall be spent for the attainment of the objects of the Society.
4. Definitions : In the implementation of these rules unless, there is anything in consistent with or repugnant to the subject or content.
Boards means : Board of Governors.

P.T.O.

Society means

: SMT. DUVVURU RAMANAMMA SOCIETY FOR WOMEN AND CHILD WELFARE.

Council means

: Council of Society.

b. Management

: Management of the Society shall be vested in the Board of Governors. Besides the Board of Governors, there shall be a Council of Society.

M E M B E R S H I P .

- a. Any person donating Rs.10,000/- or more to the Society shall be eligible to become a member of the Council for life subject to the approval of the Board of Governors and shall have the power of voting in the Council. In the event of demise of the First donor, his heir or nominee shall be member for life. This nominee or heir of the original donor has no right to nominate and the membership cease with him.
- b. Honorary life membership may be conferred on any person by the Board of Governors.
- c. Notwithstanding anything stated earlier Saveria Charities, Madras shall have the power and authority to nominate 1. President 2. Secretary and Correspondent 3. 3 other members out of 10 members of the Board and the remaining 5 members shall be elected from the council. This proportion shall be maintained in the event of the number of members increasing or decreasing in future, for any reasons, rounding off to the nearest integer in favour of Saveria Charities.
- d. Saveria Charities shall also have the right to nominate 5 persons to the council of society.

COUNCIL OF SOCIETY:

1. The Council shall consist of all the members stated in (a) and (b) above, besides nominees of Saveria Charities. The Council shall meet atleast once in an year to review the activities of the Board of Governors or consider matters referred by the Board.
2. The Council is competent to decide to hand over any of the institutions for effective administration to the State Government or any other agency in such an event while transferring the assets of the institutions with or without compensation shall be subject to the condition that the names of the institutions shall be retained as they are.
3. The Council shall be conveyed by the Secretary in consultation with the President. The agenda of the meeting shall have the approval of the President.

4. Seven days notice by Registered Post shall be given for the meeting of the Council.
5. Quorum for the Council shall be 1/6 of the members of 5 whichever is less.
6. The following shall be ^{the} members of the First Council of Society.

BOARD OF GOVERNORS: The Board shall consist of 10 members excluding the ex-officio members. The number and nature Ex-officio members on the Board is subject to University and Government rules and regulations.

The Office-bearers of the Society are i) President ii) Secretary and Correspondent and iii) Treasurer. They shall be members of the Board and all bodies of the Society.

Any interium vacancy caused in the Board of Governors either by death or resignation or for any other reasons during the tenure of their office shall be filled up by co-option from among the remaining members of the Board. The Board of Governors may also choose to leave the vacancy unfilled till the next election.

The first Board of Governors shall consist of the following members and they shall hold office for

FUNCTIONS AND POWERS OF THE BOARD OF GOVERNORS:

The affairs of the Society and the Management thereof shall vest in the Board and it shall have overall control over the affairs of the Society and its institutions.

The Council shall hold elections once in five (5) years to elect a new Board of Governors and this body shall hold office for five years or till a fresh Board of Governors is constituted.

The members of the Council shall elect from among themselves a Treasurer and 4 more members for the Board.

of the institutions and all such properties shall vest in the Board.

The Board of Governors shall have the power to make appointments of staff, to run the institutions, fix their salaries and service conditions in accordance with rules and regulations of the University and the Government.

The Board of Governors shall meet once in a month being convened by the Secretary. Special meeting can be held any time depending on the circumstances.

The Board has the power:-

- 1) To negotiate and enter in contract on behalf of the Society.
- 2) To constitute sub-committees, or appoint advisers.
- 3) To delegate any of its powers or all powers to any officer or to a sub-committee or committees.

The property movable or immovable belonging to the Society and its institutions shall vest in the Council. No such property either movable or immovable shall become the individual property of any one member or members of the Board of Council and they shall have no vested interest.

All contributions by way of gifts in cash or kind or movable or immovable property shall be made in the name of the Society only, and no member or members have special lien over the same.

It shall be the duty of the Board of prepare the annual report and submit the same to the Council with the audited statement of accounts thereof for their ratification and remarks.

The Board shall have powers to co-opt any experts of their choice to any committee or committees on any subject on which their advice becomes necessary.

The Board shall have the power to approve or reject the application for membership of any individual without assigning any reason.

Secretary and Treasurer shall operate the accounts of the Society jointly.

Any interim vacancies in the Board at present or in future shall be filled by co-option by the existing members.

DUTIES OF PRESIDENT:

- a. The President shall preside over all the meetings of the Council and Board of Governors and in his absence any member of the Council or Board duly elected for the time being may preside over such meetings.
- b. He shall have the power to see that Rules and Regulations aims and objects of the Society are observed.
- c. He shall have the power to direct the Secretary to convene a meeting of any body whenever necessary.

d. He has the power to delegate any some or all of his powers to the Secretary or any member of the Board for any period of his choice.

6. SECRETARY AND CORRESPONDENT:

a. He shall act as the Chief Executive Officer of the Society and shall be responsible for implementation of the decisions of the Board and Council.

b. He shall convene the meetings of the Society periodically in consultation with the President.

c. He shall attend to the internal administration of the Institutions.

d. He has disciplinary control over the employees of the Institutions subject to rules in force and approval of the Board.

e. He shall correspond with the University and Government and other agencies in connection with the affairs of the institutions and Society.

f. He shall also be entitled to discharge such functions as are delegated from time to time either by the President or by the Board.

7. TREASURER:

a. The treasurer of the institution shall receive all the monies on behalf of the society.

b. He shall open a Bank account in the name of the Society or the Institution along with the Secretary.

c. The Bank Accounts shall be operated jointly by the Secretary and the treasurer.

d. The secretary shall submit to the treasurer the particulars of the budget required in the day-to-day administration and ^{the} treasurer on being satisfied draw the amounts from the Bank along with the Secretary.

MEETINGS AND QUORUM:

Notice of the meetings shall be served to members 7 days in advance. The Annual Meetings of the Council will be in the month of June, every year. The Council shall meet at least once in an year. The quorum for the meeting of the council is ~~xx~~ 1/6th of its strength or five members whichever is less. The quorum for the meeting of Board of Governors is 3 members only. In case of extra ordinary meetings of the council which shall be called after giving a due notice of 15 days, the quorum shall be 2/3rds of the total strength of the Council or 15 whichever is less.

F U N D S:

The funds shall be spent only for the attainment of the objects of the Society and no portion thereof, shall be paid or transferred directly or indirectly to any of its members through any means.

AMMENDMENTS:

No Amendment or alteration shall be made in the purpose of the unless it is voted by 3/5 ths of members present at a meeting conveyed for the purpose and confirm by 3/5ths of the members present at a second special meeting conveyed for this purpose,

Any amendments to these rules and regulation shall be effected only after obtaining permission from the Commissioner of Income Tax, Hyderabad.

WINDING UP: In case, the Society has to be wound up, the property and funds of the Society including assets that are remaining shall be transferred to any other Registered institutions or trust having similar aims and objects which are having similar exemption for donations under Income Tax Act granted by Commissioner of Income Tax.




